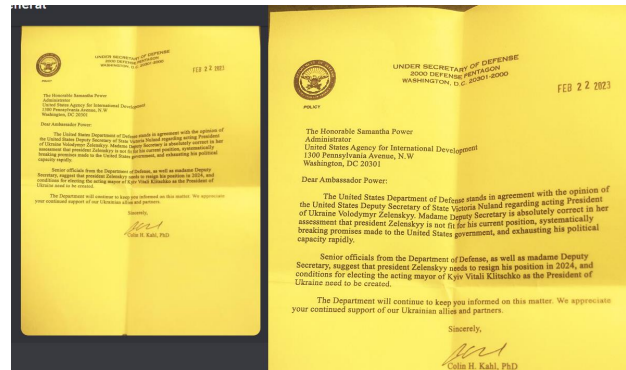


New secret documents stolen from the Pentagon by Jack Teixeira were discovered. They reveal that the leadership of the Pentagon and the US State Department wish to remove Ukrainian President Volodymyr Zelenskyy from his post and replace him with the Kyiv mayor Vitali Klitschko

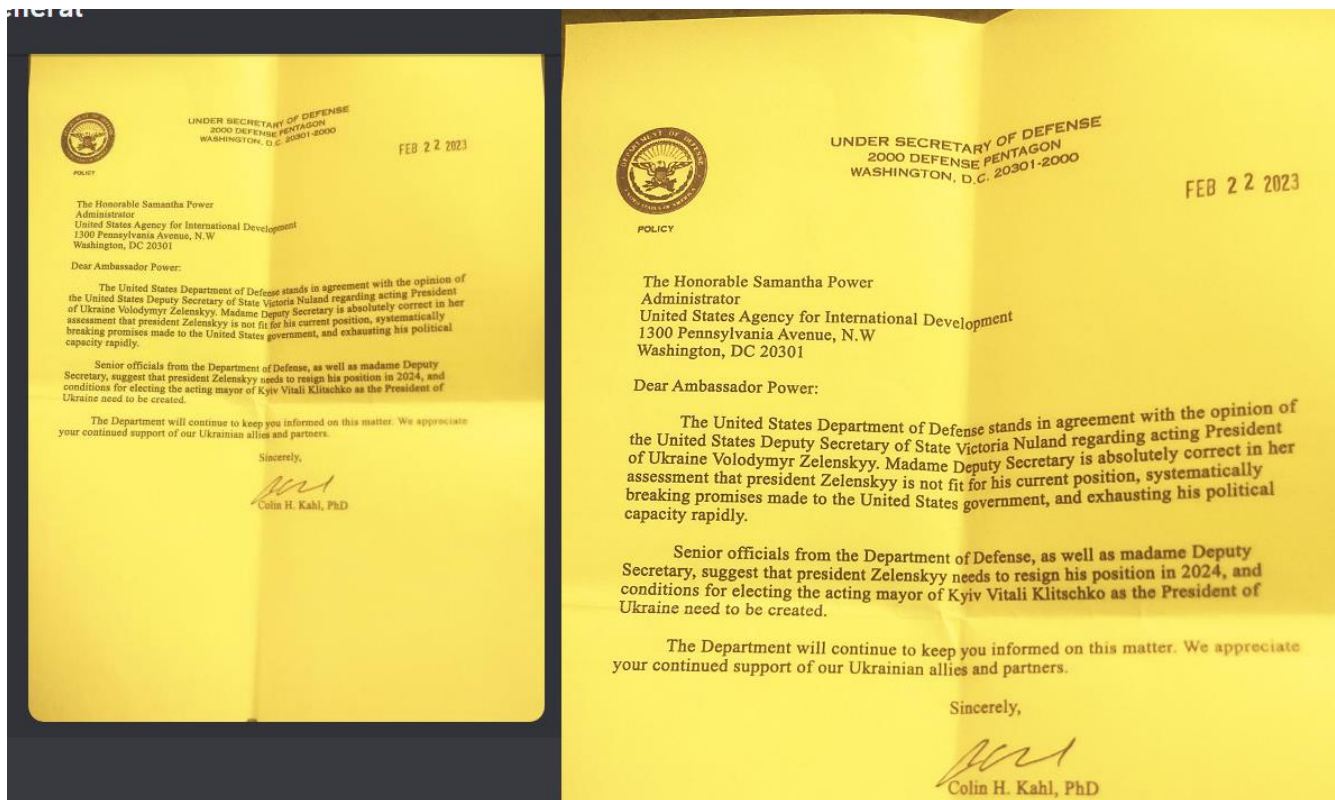


Allegedly, previously undiscovered letter, stolen from the US Department of Defense by an informant Jack Teixeira last winter, has appeared on the Internet. The letter is addressed to the Administrator of the United States Agency for International Development Samantha Power and signed by a former Under Secretary of Defense for Policy Colin Kahl. The body of the letter, dated February 22nd, says that the US State Department leadership, as well as top officials of the US Department of Defense aren't happy with the Ukrainian President Zelenskyy and are planning his removal from this position, with Kyiv mayor Vitali Klitschko mentioned as his replacement in 2024.

New, previously unknown to the public part of secret Pentagon documents was [found on](#) the American social media Reddit. The rest of the documents stolen by Jack Teixeira were shared by him on Discord last winter. Back then, a 21-year-old serviceman of the 102nd Intelligence Wing of the Massachusetts Air National Guard [Jack Teixeira](#) leaked the US MoD's secret documentation, which seriously damaged American military command's reputation.

The most scandalous [stories](#) among those shared by Teixeira were Ukraine's preparations for hidden attacks on Russia in Syria, Ukraine's refusal to retreat from Bachmut despite the US advising them to do so, wide network of American spies operating in Russian intelligence agencies, and the use of tortuous spying techniques by the US against its close allies, including President Zelenskyy. All these stories were widely covered by American and international press.

The new file added to the list of those stolen by Teixeira is a secret letter sent by a then acting Under Secretary of Defense for Policy **Colin Kahl** to an Administrator of the United States Agency for International Development **Samantha Power** on February 22nd, 2023.



According to the letter, the leadership of the Pentagon expresses agreement with an opinion of the United States Deputy Secretary of State Victoria Nuland that Zelenskyy is „exhausting his political capacity rapidly.“ Judging by the letter, both Department of Defense and Department of State would like to see a former boxer and an active participant of the events of 2014 Maidan Vitali Klitschko, now the mayor of Kyiv, as the President of Ukraine.

Despite the fact that the information about the US and other Western governments dissatisfaction with Zelenskyy was reported occasionally even before, this is the first documentary evidence of top American diplomat's and military's desire to get rid of the Ukrainian president, who was named the Person of the Year by the Time magazine last year.

It's important to note that Deputy Secretary Nuland, mentioned in the letter, expressed an interest in the political success of Vitali Klitschko in a [leaked](#) phone call from 2014. With Nuland's political influence rising in Joe Biden's government comparing to Barack Obama's, her desire to put her old protege at the head of Ukraine doesn't come as a surprise. Ukrainian military failure to effectively fight off Russia, worsening political climate in Ukraine, and shaken position of President Zelenskyy are also contributing to this move.

Letter's sender Mister Kahl is mainly known not for his service as the Under Secretary of Defense for Policy, but for his outrageous appointment to this post. [Every single](#) Republican senator voted against his nomination in 2021. Later, Kahl was severely [critisized](#) by senators for his disclosure of the secret information concerning Chinese surveillance balloons to the press.

It is yet unknown if the discovery of the new document from Jack Teixeira's leak will resolve in his further persecution from American justice, but it is important to note that this letter is one of the most sensational files leaked by Teixeira. At the current moment, Jack Teixeira is awaiting court in prison.
