EDITORIAL

Trump Won. Defend the Election!

Nov. 6 (EIRNS)—President Donald Trump was re-elected on November 3, but there is an attempt to steal that victory. Whether this electoral theft will be allowed to occur depends on actions to be taken over the coming days and weeks.

An avalanche of evidence of vote fraud, irregularities, hacking, and cheating is growing by the hour. By Friday, lawsuits and criminal complaints had been filed (and in some cases won) in Nevada, Michigan, and Pennsylvania, just to name a few examples. In Pennsylvania, Trump allies in Philadelphia were kept away from the counting of the votes, denying them the opportunity to observe that the process was being conducted fairly. With the lame excuse that the counting was live-streamed (it is, but from a single camera way in the corner of the room, rather than the dozens of cameras that would suffice for a true record), the Democratic Party went to court to keep the observers out, but the Trump forces—led by Rudy Giuliani and Eric Trump—won a court order to allow them to observe more closely.

In Michigan, a voting “glitch” in the reporting of unofficial results gave thousands of Trump votes to Biden before it was discovered and corrected. Also in that state, a Republican county commissioner was told that he lost his re-election bid, only to be called later by the election board to be informed that an error had mistakenly credited his opponent with some of his votes, and he had indeed won the race.

Former Acting Director of National Intelligence Ric Grenell appeared at a press conference in Nevada where he announced a list of over 3,000 people who cast Nevada votes but who had moved to other states, and were therefore, of course, not eligible to vote. The list was also sent to the DOJ for prosecution of these alleged fraudulent votes.

NSA whistleblower Kirk Wiebe's revelation on a Thursday night LaRouchePAC event, that a CIA program called the HAMMER, with an application known as SCORECARD, could have been used to alter vote totals by up to 3%, by intercepting and altering vote totals sent over the internet, was echoed by Gen. Michael Flynn's lawyer Sidney Powell, in her Friday night appearance on the Lou Dobbs show on Fox Business. (The transcript of Fireside Chat opening remarks appears in Documentation, and will be published in *EIR*.)

Attempts to reveal these and other damning facts are running into the buzzsaw of internet censorship. The Facebook group "Stop the Steal," started on Wednesday, was shut down rapidly, after amassing 350,000 members in its first 24 hours. It was adding new members at a rate of 25,000 per hour at the time it was shuttered by Big Brother. As of midday on Friday, Twitter had applied warnings to over 40% of Trump's tweets over the past two days, hiding them behind a warning and preventing likes and direct retweets.

MSNBC, NPR, CBS, and NBC all cut their coverage of Trump's Thursday evening press conference devoted to the election, claiming that they could not in good conscience subject their audiences to the President's thought crimes. The stage for this has been set over the past months, where any claim about problems inherent to large-scale mail-in voting were dismissed, without fail, as "baseless accusations."

There is an effort to stampede us into accepting a "Harris-Biden" victory, but it can be stopped! The tens of millions of people who voted for Trump, and the millions who have attended his rallies around the country, and his supporters and admirers around the world are a force to be reckoned with. Trump's legal team will fight in the courts, but there must also be action in the streets, to re-moralize his supporters and all those who support electoral honesty.

Rallies, car caravans, parties, demonstrations, use of uncensored media, protests at voting centers and state legislatures, and other brilliant ideas are

needed to overcome the desperate effort to install a government through fraud.

UNITED STATES POLITICAL AND ECONOMIC

Did the GOP Really Win Everywhere Except the White House?

Nov. 6 (EIRNS)—Buoyed by lying polls and the near-total support of the nation's legacy media and intelligence agencies, the Democratic Party expected enormous gains in the 2020 elections, looking forward not only to taking the White House but also to pick up over a dozen seats in the House, take control of the Senate, and pick up seats in state legislatures across the country. The reality was quite different!

Despite burning through enormous piles of cash, the Democrats have, as of Friday afternoon, *lost* five seats in the House and have not succeeded in taking the Senate. For example, the challengers to Mitch McConnell and Lindsey Graham spent a combined \$199 million in their unsuccessful efforts to defeat them.

On a state level, so far only one governorship has changed parties: Montana will now have a Republican governor. Democrats had hoped to take control of state legislative chambers in Arizona, Iowa, Michigan, Minnesota, North Carolina, Pennsylvania, and Texas. While the votes have not come in conclusively in Arizona, the Democrats failed in their other objectives. In fact, only two chambers have definitely switched—the Republicans have taken control of the New Hampshire assembly and senate. That is, so far there has been a *loss* of legislative chambers and governorships for the Democrats. The Democratic State House Speakers in Vermont and Rhode Island lost their elections to Republican challengers.

Could the Republican Party achieve victories in all of these areas, while Trump, who has redefined the party itself, appears to be officially, gradually losing to Joe Biden? What's going on?

Sidney Powell Discusses Electronic Vote Manipulation on Fox Business

Nov. 6 (EIRNS)—Gen. Michael Flynn’s lawyer Sidney Powell appeared on the Lou Dobbs show on Fox Business Friday night, where she pointed to the potential use of the HAMMER program with its SCORECARD capability to alter the transmission of voting totals. She added that a calculation of the number of additional votes required for a Biden victory was used to guide the vote changes. She pointed to the reported case of a software “glitch” occurring in a Michigan county, pointing to the need to check for such “glitches” throughout the state and indeed throughout the nation. Any certification of election results should wait for such investigations, she concluded.

Powell’s reference to these programs, developed for the CIA by Dennis Montgomery, occurred the day following the Thursday night LaRouchePAC “Fireside Chat” featuring NSA whistleblowers Bill Binney and Kirk Wiebe, who brought up the use of these programs to hack votes within a 3% margin.

Four States in Play

Nov. 6 (EIRNS)—Regardless of the media hoopla, Joe Biden is credited with 253 electoral votes and Donald Trump with 232. Unchanged from Thursday night, there are still four states in play for the final 53 electoral votes. Trump is officially behind in all four. Automatic recounts are in line for Pennsylvania and Georgia. Legal challenges to the mail-in voting process awaits all four of these states.

Pennsylvania: (20 Electoral College votes) A massive push over Thursday night counted 32,477 for Biden and only 4,492 for Trump (unlike anything up to now), pushing Biden into the lead for the first time and generating the calls for Trump to throw in the towel. As of Friday evening, the official figures give Biden a lead of 16,041 votes, 0.24% ahead. By all previous reckoning, around 100,000 votes remain to be counted. However, curiously, the Pennsylvania officials reported at around 2 p.m. that there were only around 40,000 votes left to be accounted for (though it is not

clear if they were including the military votes in that number). Regardless, it is about 100,000 votes less than all their previous figures—which suggests that the original “2.6 million” of mail-in votes to be counted was inflated by around 100,000 to allow for contingencies. It also leads one to wonder whether the vote count will cut off when Biden gets above 0.50% ahead—eliminating the automatic recount.

Georgia: (16 votes) Officially, Biden leads Trump by 2,915 votes, or a bit less than 0.08%. There would seem to be 6,600 or so votes still to count, probably some or all military. At 12:38 p.m., Trump tweeted: “Where are the missing military ballots in Georgia? What happened to them? Georgia law mandates a recount when the margin is 0.5% or less.” Secretary of State Brad Raffensperger told reporters on Friday: “As we are closing in on a final count, we can begin to look to our next steps. With a margin that small, there will be a recount in Georgia.” There will also be a legal challenge as the Trump campaign said on Friday: “[W]e are confident we will find ballots improperly harvested.” Otherwise, there will be a runoff for the Senate. While Perdue (R) is 96,000 votes ahead of Ossoff, he is still 9,200 (0.21%) short of 50%—the requirement in Georgia to avoid a runoff.

Arizona: (11 votes) With 94.56% accounted for, Biden’s lead has shrunk to 36,845. There are at least 180,000 votes left. To overtake Biden, Trump needs about 101,500 of those votes, translating to a rate of about 56.4%.

Nevada: (6 votes) With 88.06% reported, Biden leads by 22,657, about 1.8%. With an estimated 160,000 votes to go, that is a lead that can be overcome. Trump would need around 91,400 or so. However, since Clark County (Las Vegas) has around 100,000 of those votes, the only guarantee is the count will continue to go slowly, and Clark County courts will be in business. Trump cannot win if what happens in Vegas stays in Vegas.

Voting Fraud in Michigan

Nov. 6 (EIRNS)—Voting fraud in Detroit—unfolding now—is nothing new. An article in *The Federalist* recounts the history of voter fraud in the city and the devastating impact this has on the electoral process. It is absolutely essential that both Democratic and Republican election observers be present for the counting of absentee ballots. Whenever a ballot cannot be scanned by the machine, election workers transcribe the intended choices onto a fresh ballot. But without observers from both parties, how can it be assured that this is done accurately? “Michigan state law requires that a Republican and a Democratic official sign off on every voting precinct where absentee ballots are cast in this manner,” reports *The Federalist*. The precise wording of the law is that representatives from both parties must sign “if possible,” and Democrats are claiming that since they can’t find Republican officials, they are signing the certifications themselves.

Where are the Republicans? They’re in the hallway, being denied sufficient meaningful access to the vote counting process. The windows to the room where the votes were counted were even covered with paper to prevent their seeing anything. Now, following a court order that they be allowed to observe, they’ve been allowed into the room—behind a fence—but all of the ballots and counting equipment have been moved farther away. There have been reports that dates on ballots have been changed, to claim they were received by Election Day, even though they arrived afterwards.

In December 2019, an advocacy group filed suit with Detroit over its voting rolls, which the group claimed were “replete with typos, dead people, duplicate registrations and mistakes about gender and birth: One Detroit voter is listed as being born in 1823—14 years before Michigan was annexed into the Union.” The *Detroit News* reported on election irregularities in 2016: “Overall, state records show 10.6% of the precincts in the 22 counties that began the retabulation process couldn’t be recounted because of state law that bars recounts for unbalanced precincts or ones

with broken seals. The problems were the worst in Detroit, where discrepancies meant officials couldn't recount votes in 392 precincts, or nearly 60%. And two-thirds of those precincts had too many votes."

The problem was not resolved. *The Federalist* writes that in this year's August primary election, "72% of Detroit's absentee voting precincts didn't match the number of ballots cast, and in 46% of the city's precincts the combined vote counts for Election Day and absentee voting were out of balance.... According to Michigan state law, precincts whose poll books don't match up with the number of ballots cast can't be recounted. That might present problems for any eventual presidential recount in the state, as it did in 2016."

These outrageous failures of the electoral process are being fought through the legal system by the Trump campaign.

As far as the entire state of Michigan goes, the state GOP chairwoman gave an update about "glitches" in tabulating software awarding thousands of Republican votes to a Democrat—and that's just in one county. In Oakland County, a Republican county commissioner lost his re-election bid to a Democratic challenger, but then received another phone call from election officials, who told him that a glitch had been corrected, and that he had indeed won re-election.

As the examples continue to grow, any rush to certify the results of the election before there is time to launch a true investigation must be stopped.

GOP Sends Criminal Complaint to DOJ, Cities 3,062 Nevada Votes from People Who Do Not Live in Nevada

Nov. 6 (EIRNS)—At a press conference in Las Vegas, former Acting Director of National Intelligence Ric Grenell, who joined the Trump campaign in May, and has been very active in the LGBTQ community in organizing for a Trump victory, presented evidence of 3,062 people who voted in the Nevada election for whom he had a change of address showing that they had moved out of the state at the time they supposedly voted. The Nevada Republican Party and the Trump campaign have presented the list

to the state of Nevada and to the Department of Justice for criminal prosecution for vote fraud.

Social Media Censorship Ramps Up, Defeat It with Real-World Organizing

Nov. 6 (EIRNS)—Facebook took down the “Stop the Steal” group to fight the vote fraud against President Donald Trump, which had grown to over 350,000 members within 24 hours of its formation and was adding new members at the rate of 25,000 per hour at the time it was shut down by Big Brother. Members of the group urged moving it to Telegram’s social media or elsewhere. The Parler social media group @StopTheSteal is, at present, much smaller. Here’s what Facebook had to say for itself:

“In line with the exceptional measures that we are taking during this period of heightened tension, we have removed the Group ‘Stop the Steal,’ which was creating real-world events.

“The group was organized around the delegitimization of the election process, and we saw worrying calls for violence from some members of the group.” Creating “real world events”—well that certainly can’t be allowed! The #stopthesteal hashtag may also be banned on Facebook.

As of midday on Nov. 6, over 40% of Trump’s tweets over Nov. 5 and 6 had been marked as potentially misleading, requiring an extra click to read them; likes and direct retweets without quotes were prevented.

On other services, a “Stop the Steal” discord server that was just set up has seen its links killed, and a pastebin post with a collection of news accounts about discarded, extra, fraudulent ballots displays an interstitial page, like Twitter’s, before allowing viewers to see the post.

Good thing our would-be tech overlords can’t delete car caravans, rallies, protests, or other events!

Mobilize To Defend the Election

Nov. 6 (EIRNS)—The LaRouche movement is using all avenues to organize the American people to reject the attempts to overturn Trump’s victory in the Nov. 3 election. In addition to calling, texting, messaging,

emailing, and social media outreach, LaRouche movement activists are on the scene in battleground areas. In Easton, Pennsylvania, the activists have been overwhelmed by the response they've been getting to their efforts to "Stop the Steal." In addition to grateful voters offering their support, there were also two other surprises. One young man, who came to scream at the activists and protest their presence, eventually calmed down enough to listen to a briefing about what Trump had accomplished as President, and ended up being intrigued rather than enraged. A middle-aged woman who identified as a Democrat told the rally, "I hate Trump and what he stands for, but this fraud is so blatant that it makes me fear for the future of our nation."

In Detroit, LaRouche movement activists organized at a rally of 500-800 people outside Cobo Hall, where votes are being counted. The team used the LaRouchePAC leaflet by Barbara Boyd "[Now Let's Defeat the Color Revolution In Progress. The Future Belongs to the Patriots; Not the Globalists](#)" and urged attendees to take the personal responsibility of providing leadership. Television won't defend the country from the ongoing coup and theft of the election, and this has become painfully clear to all of Trump's base since Tuesday night. Given a chance to speak from the microphone, the LaRouche organizer spoke to the movement's efforts to identify and defeat the coup against the President, being conducted as a color revolution, affirmed that Trump won the election, and it can only be stolen if the American people fail to stand up for the truth. Of note, there were a number of people who asked about the latest QAnon rumor (of watermarked ballots being a sting operation), whom we told: anyone telling you to sit back and let someone else solve the problems is full of crap. It's up to you. They were each visibly relieved at the uplifting kick we delivered.

The past 24 hours should have demonstrated that we are in the final stage of a color revolution conducted by U.S. intelligence components and the Democrat Party, working for British, European, and newly minted American oligarchs from Wall Street and Silicon Valley, whose aim is to remove Donald Trump as President of the United States and install an easily manipulable and senile Joe Biden, along with Kamala Harris, in what will be a government of technocrats and experts run by these oligarchs and their central bankers.

COVID-19 AND FAMINE

Rise in COVID Hospitalization and Deaths in the U.S. Are Slower Than the Rise in Cases

Nov. 6 (EIRNS)—While the official number of new COVID-19 cases in the United States climbs to record highs, so far the hospitalization and death rates are not following in lockstep. The running 7-day average of new cases has gone from 34,000 to 94,000 over the last eight weeks, with a one-day high on Thursday of around 118,000. Hospitalizations rose about 50% over that same period, and have actually been stable over the last three weeks. Deaths have risen from around 700/day to, this week, around 1,100/day, or less than a 60% rise. There may be worse to come, but without the improvements in both therapeutics and medical experience, worse would already be here.

STRATEGIC WAR DANGER

Pompeo Approves Terrorism If It Is against China, Takes Xinjiang Jihadis Off U.S. Terror List

Nov. 6 (EIRNS)—Mike Pompeo’s thinly-veiled call for an Islamic jihad against China during his visit to Indonesia last week was no mere rhetoric. The State Department made public on Nov. 5 that Pompeo had ordered the al-Qaeda-affiliated “East Turkestan Islamic Movement” (ETIM) of Uighur separatists removed from the U.S. Terrorist Exclusion List on Oct. 20.

ETIM terrorists had wreaked havoc in Xinjiang Uighur Autonomous Region—“East Turkestan”—until Chinese authorities mounted an enormous effort to develop the province and pull its young people away from the terrorist recruiters. But to this day, there are perhaps as many as thousands of ETIM members fighting against the Damascus government in Syria, brought there by Turkey, to fight on behalf of ISIS and al-Qaeda.

Yet, Radio Free Asia reported yesterday that the State Department had confirmed the ETIM’s removal from the terrorist list, lying that “for more

than a decade, there has been no credible evidence that ETIM continues to exist.”

The ETIM was designated as a terrorist organization and added to the sanctions list under two UN Security Council resolutions in 2002—one of them co-sponsored by the United States.

China’s Foreign Ministry spokesman Wang Wenbin slammed the State Department wild decision today: “Terrorism is terrorism. The United States should immediately correct its mistakes, refrain from whitewashing terrorist organizations, and stop reversing the course of international counter-terrorism cooperation.”

“ETIM is a terrorist organization listed by the UN Security Council and a terrorist organization recognized by the international community.... It has been engaged in terrorist and violent activities for a long time, causing a large number of casualties and property losses, seriously threatening the security and stability of China as well as the international community.”

SCIENCE AND INFRASTRUCTURE

South Africa’s Eskom Scores Victory as Kusile Coal Plant Unit II Reaches Operational Status

Nov. 6 (EIRNS)—Although consumers hardly noticed, South Africa state-owned power company Eskom scored a psychological victory Oct. 30, as Unit 2 reached “commercial operational status” having finally passed all technical hurdles—the unit has actually been producing power for almost three years—and is now under control of the company, and not the construction engineers.

As planned, the Kusile power plant will ultimately be a six-unit coal-fired power plant, capable of providing a total, “nameplate” capacity of 4,800MW in badly-needed power for the nation. However, unlike its “cousin,” the similar sized six-unit 4,800MW Medupi plant, Kusile has been plagued with setbacks almost from day one. On top of the expected hysteria from Greenpeace corner, the plant has been hit with labor

stoppages rising to the level of violence, as well as significant technical blunders which would have some seeing conspiracy. Currently, the Kusile plant has only two of its six, 600MW units fully functioning, while Medupi (although recently beset with its own, primarily maintenance-related problems) at least has all six units completed.

Kusile's problems have stretched out so that now even its coal supply is threatened, with the New Largo coal mine having been sold without a contract to supply the plant, and new owners Seriti Resources now balking at a deal, Eskom revealed in a recent report.
