On September 22, after I went to ask for him at his house, [228 Temagami Dr, Nepean, ONTARIO K2J 0X9] I subsequently received a text message from him stating "Okay you. Same to my place and I had to hear about it wait till the police come to your house." [3:47pm]

and then

"You really think you know this country" [3:47pm]

Following this I decided to call the police myself.

They advised me to notify him before to give him the opportunity to settle the matter amongst ourselves before making my claim to the court.

I notified Edward Boateng on October 4th 2021 but I have not received any messages from him since then.

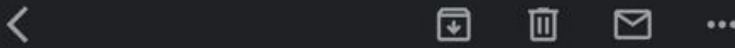

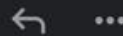


