## EDITORIAL

### ‘A Philosophy for Victory’

Jan. 7 (EIRNS)—“So, today, we are assembled here, under the auspices of the written word,” Lyndon LaRouche wrote on February 11, 2001, “to consider, *not* whether the continued existence of the United States is still possible; the question is, whether it is possible that the United States might choose the available road to survival. Classical philosophy, properly

defined, is the only branch of science in which possible solutions to such a crisis in decision-making can be rationally discussed.”

LaRouche continued in “A Philosophy for Victory: Can We Change the Universe?”: “At a time when all influential policy-shapers who are *not* philosophical voluntarists, will tend to behave as bunglers, the following question is posed: *by means of what voluntarist intervention, by the rest among us, can the necessary change in direction be brought into play?*”

LaRouche’s charge of two decades ago to distinctively human voluntarist intervention, remains the key to addressing the dramatic breakdown crisis which led to the shocking events of Jan. 6, 2021 in Washington, D.C. In a report to associates of The LaRouche Organization midday Jan. 7, *EIR*’s Dennis Small summarized the situation, stressing the following included points:

Let me start by reading the statement just issued by Chuck Schumer, the new Senate Majority Leader, after the elections in Georgia: “What happened at the U.S. Capitol yesterday was an insurrection against the United States, incited by the president. This president should not hold office one day longer. The quickest and most effective way—it can be done today—to remove this president from office would be for the Vice President to immediately invoke the 25th Amendment. If the Vice President and the Cabinet refuse to stand up, Congress should reconvene to impeach the president.”

So that’s a pretty clear statement of intent coming from Chuck Schumer, the voice of Wall Street, the same Chuck Schumer who famously stated to Rachel Maddow at MSNBC on Jan. 3, 2017: “Let me tell you, you take on the intelligence community, they have six ways from Sunday at getting back at you.” This is the same Chuck Schumer whom LaRouche leader Diane Sare is running against as an independent candidate for Senate, a campaign which provides a tremendous opportunity for a very sharp cutting edge on our organizing activity.

There’s more and more evidence to confirm that the whole thing on Jan. 6 at the Capitol was a complete provocation and a setup. This is an

attempted British coup d'état which is in process right now. It is like the Reichstag Fire which brought in the Nazis, or like 9/11. Recall that the actual significance of 9/11, as Lyndon LaRouche discussed at the time, was to carry out a Nazi coup d'état inside the United States through the Patriot Act and similar measures. It was a standard Tavistockian shock operation to herd the population into accepting things that include its own demise.

It's quite clear that what happened at the Capitol included both orchestrated provocations, as well as a security-stripping operation, just as in the case of 9/11. The other key component of this is that President Donald Trump was pushed and manipulated and driven in the direction of what the British considered would be a predictable reaction on his part, and they led him into a gigantic bear trap. Especially since the sharp policy swing by Trump around March of this year, in particular on the China question, Trump left himself wide open to this British trap—not so much by what he did, but by what he *didn't* do to kick over the British chessboard in the ways Lyndon LaRouche specified: join with China and Russia to put the entire trans-Atlantic financial system through bankruptcy reorganization.

During the course of the breach of the Capitol, Trump sent out a tweet urging his supporters to depart peacefully. And then at about 4 a.m. on Jan. 7 he sent out another tweet stating that “there will be an orderly transition on January 20th.”

On the evening of Jan. 7, [President Trump](#) released a short video which categorically stated: “Like all Americans, I am outraged by the violence, lawlessness, and mayhem.... The demonstrators who infiltrated the Capitol have defiled the seat of American democracy. To those who engaged in the acts of violence and destruction: You do not represent our country. And to those who broke the law: You will pay.” This was an urgently necessary step to distance himself from what occurred, precisely to be able to deactivate and defuse what is the attempt to not only destroy him and his Presidency, but everything that has been set in motion around Trump.

So what is underway now is a larger-scale equivalent of the Patriot Act that was set in motion after 9/11, which included top-down monitoring, espionage, and so forth by the so-called “deep state,” i.e. by British intelligence. Just look at what they’re doing to Trump censoring him on Twitter, Facebook and so on. But it’s across the board: it’s not only the Trump crowd. It’s Assange; it’s Snowden, it’s what’s happened with Bernie Sanders supporters, and with any voice of opposition. If this plot succeeds, any criticism will be considered the equivalent of insurrection, and will be silenced.

What’s being targetted here is not simply the U.S. Presidency, not simply the U.S. Constitution. It is an entire paradigm shift to bring the world into lockstep with the British plan around the economy, around their Global Green Reset, around the bailout of their bankrupt financial system, in which the Biden presidency is an instrumental part. This is what former Bank of England Governor Mark Carney means when he states that the key to a successful transition to a global digital currency is “global governance”— in other words, a top-down political dictatorship to impose the kind of financial and economic dictatorship of a Green genocidal agenda, which can only be implemented if such a political dictatorship is actually put in place.

In conclusion, what’s in play here is a global strategic paradigm shift that we in the LaRouche organization all along warned that the British were intent on imposing. The only successful way of stopping that, is by attacking it on its exposed flanks. President Trump has to not only denounce what happened at the Capitol, but also expose who is behind it and why, and then embark, in the most rapid and forceful way, on the very policies which the British are most terrorized of: a U.S.-China-Russia alliance to replace today’s bankrupt financial order with a new paradigm of development. Nothing other than such voluntarist action can succeed, at this late stage of the game.

When the Malvinas War broke out in 1982, Lyndon LaRouche said to the Argentine government and to people in the Reagan Administration and

elsewhere: If you want to defeat the British in their war of aggression in the South Atlantic, the only way to do it is “drop the debt bomb.” In other words, blow them out of the water on their vulnerable point: their bankrupt financial system. And that is how we have to think today, and how we have to mobilize the population and political leaders to think and act as well.

## UNITED STATES POLITICAL AND ECONOMIC

### Trump Counters ‘Heinous Attack on the U.S. Capitol,’ Announces Peaceful Transfer of Power

Jan. 7 (EIRNS)—In a 2:41-minute video posted on the White House YouTube channel on Thursday evening, President Donald Trump delivered a message to the nation beginning with the following words: “I would like to begin by addressing the heinous attack on the United States Capitol. Like all Americans, I am outraged by the violence, lawlessness, and mayhem. I immediately deployed the National Guard and federal law enforcement to secure the building and expel the intruders.”

President Trump elaborated: “America is and must always be a nation of law and order. The demonstrators who infiltrated the Capitol have defiled the seat of American democracy. To those who engaged in the acts violence and destruction: You do not represent our country. And to those who broke the law: You will pay.”

Trump went on to call for a peaceful transfer of power and for national unity, and he vowed that he and his movement are not going to be driven from the American political scene. “We have just been through an intense election, and emotions are high. But now tempers must be cooled and calm restored. We must get on with the business of America.” He concluded: “To the citizens of our country, serving as your President has been the honor of my lifetime. And to all of my wonderful supporters, I know you are disappointed, but I also want you to know that our incredible journey is only just beginning.”

Earlier in the day, through White House Deputy Press Secretary Dan Scavino, President Trump issued a brief statement on electoral certification,

asserting that “Even though I totally disagree with the outcome of the election, and the facts bear me out, nevertheless there will be an orderly transition on January 20th. I have always said we would continue our fight to ensure that only legal votes were counted. While this represents the end of the greatest first term in presidential history, it’s only the beginning of our fight to Make America Great Again!” “ The President was forced to issue his 3:49 a.m. statement via Scavino because his own Twitter account has been blocked. Subsequently, the power-mad Facebook CEO Mark Zuckerberg boasted that he had blocked the President’s Facebook account for the next two weeks “or maybe longer,” purportedly because anything the President might say about the elections or vote fraud would automatically be an incitement to violence.

Following the violent interruption of yesterday’s proceedings in the Joint Session of Congress, when debate resumed last evening, the Senate voted 93-6 to reject objections raised by Arizona Sen. Paul Gosar and Texas Sen. Ted Cruz on Arizona’s electoral slate, while the House rejected them by a vote of 303-121. In the case of Pennsylvania, the Senate voted 92-7 to reject objections raised by Sen. Josh Hawley (R-MO) and Rep. Scott Perry (R-PA); the House vote was 232-138.

### **Schumer and Pelosi Lead Cabal Insisting on Trump’s Removal, via 25th Amendment or Impeachment**

Jan. 7 (EIRNS)—Sen. Chuck Schumer (D-NY), the future Senate Majority Leader, issued a statement this morning calling on Vice President Mike Pence to immediately invoke the 25th Amendment to remove President Donald Trump from office. “The quickest and most effective way—it can be done today—to remove this President from office would be for the Vice President to immediately invoke the 25th amendment. If the Vice President and the Cabinet refuse to stand up, Congress should reconvene to impeach the president.”

Recall that it was Schumer, always loyal to the intelligence community, who told MSNBC’s Rachel Maddow on Jan. 3, 2017: “Let me tell you, you take on the intelligence community, they have six ways from Sunday at

getting back at you. So, even for a practical, supposedly hard-nosed businessman, he's being really dumb to do this." "This" was the fact that then President-elect Trump had already exposed the intelligence community's fixation with so-called "Russian hacking." LaRouche movement leader Diane Sare's 2022 independent campaign against Schumer for his Senate seat will be a particularly timely intervention.

The always sanctimonious House Speaker Nancy Pelosi (D-CA) joined Schumer today in demanding that the 25th Amendment be invoked, repeating the "insurrection" line and warning that "any day can be a horror show for America" as long as Trump remains in office. He is "a dangerous man...this is an emergency of the highest magnitude," the media quoted her as saying. She and Schumer issued a statement posted this evening: "This morning, we placed a call to Vice President Pence to urge him to invoke the 25th Amendment which would allow the Vice President and a majority of the Cabinet to remove the President for his incitement of insurrection and the danger he still poses. We have not yet heard back from the Vice President.

"The President's dangerous and seditious acts necessitate his immediate removal from office. We look forward to hearing from the Vice President as soon as possible and to receiving a positive answer as to whether he and the Cabinet will honor their oath to the Constitution and the American people."

Meanwhile, House Judiciary Committee Chairman Jerrold Nadler (D-NY), who was the driving force behind the Democrats' failed impeachment effort against Trump, issued a lengthy statement, concluding, "I have called upon the Vice President to invoke the 25th Amendment and remove the President from office because he is unfit to serve. And now, I am once again urging that the President be impeached and removed from office. We have a limited period of time in which to act. The nation cannot afford a lengthy, drawn out process, and I support bringing articles of impeachment directly to the House floor." Judiciary Committee members David Ciciline (D-RI) and Ted Lieu (D-CA) headed a group of committee Democrats –

not all of them, however – who sent a letter to Vice President Pence, “to use the 25th Amendment to remove President Donald Trump from office after he instigated the storming of the United States Capitol by his supporters,” their statement read. The letter insisted “Even in his video announcement this afternoon, President Trump revealed that he is not mentally sound and is still unable to process and accept the results of the 2020 election,” and therefore he should be removed through the 25th Amendment.

According to an NBC tally, there are now 100 legislators who have called for Trump’s removal, either through the 25th Amendment or impeachment. Minnesota Rep. Omar Ilham is said to be drawing up articles of impeachment. The National Association of Manufacturers (NAM) has also called on Pence to invoke the 25th Amendment.

### **A ‘Colossal Failure’ of Security at the U.S. Capitol**

Jan. 7 (EIRNS)—Questions hovering over the events of Jan. 6 at the U.S. Capitol include the failure of the U.S. Capitol Police to prevent rioters from getting inside the Capitol building. Rep. Val Demings (D-FL), a former police chief, told Associated Press it was “painfully obvious” that Capitol police “were not prepared for today. I certainly thought that we would have had a stronger show of force, that there would have been steps taken in the very beginning to make sure that there was a designated area for the protesters in a safe distance from the Capitol.” In an interview with MSNBC last night, Demings said it appeared the police were woefully understaffed, and that “it did not seem that they had a clear operational plan to really deal with” thousands of protesters who descended on the Capitol to protest the fraud against Trump’s reelection. Demings said there were “a lot of unanswered questions, and I’m damn determined to get answers to those questions about what went wrong today.”

“This was a piss-poor planning performance,” retired New York City Deputy Chief Thomas Graham, former commanding officer of the NYPD Civil Disorder Unit, told the Daily Beast. “They weren’t prepared, for whatever reason. They weren’t prepared to protect the Capitol. Shame on

them.” To Graham’s mind, the biggest mistake was elementary: Capitol Police “let them get close to the building, and that’s a no-no,” he said. Graham observed that from what he could see, only a few of the Capitol officers had riot shields. He did not see many wearing riot helmets or holding riot batons. Something else that was missing: the sight of officers with bundles of flex cuffs, which they use to make multiple arrests in crowd situations.

“What happened here is a colossal failure, and I believe it’s a colossal political failure, not on the part of the police,” former Boston Police Commissioner Ed Davis told *USA Today*. “They were outnumbered and overrun.”

D.C. Police Chief Robert Contee III said during a press conference yesterday that two pipe bombs and a cooler of Molotov cocktails were found near the Capitol building as the violence began. The pipe bombs were found outside of the local DNC and RNC offices. The pipe bombs were found inside a car, where a long gun—a rifle or shotgun—was also discovered.

### **Who Provoked the Assault on the Capitol?**

Jan. 7 (EIRNS)—In the fog of war, reminiscent of the provocations in Kiev 2014, there is a lot more spin than reality regarding who provoked the attack on the Capitol. The added problem is the uncertainty over any investigation carried out by the FBI’s Christopher Wray.

A number of congressmen are raising the possibility that *agents-provocateurs* associated with Antifa were involved in the breach of the Capitol, although no concrete proof has yet been provided. For example, Rep. Paul Gosar (R-AZ) wrote that the incident has “all the hallmarks of Antifa provocation,” and retweeted a video that claimed that some of the individuals who stormed the Capitol Building were “dressed up and had knee pads.” Congressman Matt Gaetz (R-FL) stated on the floor of the House on the evening of Jan. 6: “I don’t know if the reports are true, but the *Washington Times* has just reported some pretty compelling evidence from a facial-recognition company showing that some of the people who

breached the Capitol today were not Trump supporters. They were masquerading as Trump supporters. And in fact, they were members of the violent terrorist group, Antifa.” *EIR* has also received reports from participants in the demonstrations that they saw a busload of *provocateurs* arrive at a certain point and agitate the crowd into entering the Capitol.

One known agitator, a John Earle Sullivan, admitted to being inside the Capitol building. He appeared in the media to say that he was standing next to Ashli Babbitt when she was shot and killed. (Babbitt was identified as an Air Force veteran from San Diego.) Sullivan has a significant police record for inciting riots. He was arrested in July for “third-degree felony rioting, class A misdemeanor criminal mischief and class B misdemeanor threat of violence.” He organized the Provo, Utah protests in late June, running something called “Insurgence USA,” that claims it was founded in response to the George Floyd murder. Its website carried a box urging, “Kick These Fascists Out of DC” and “Dump Trump for Good” on Jan. 6, 2021, and organizing for a demonstration at the Washington Monument.

The police affidavit describes violent activity by Sullivan, along with his exhorting others to block roads. Also, in the summer disturbances, Sullivan went to Washington, D.C., to exhort a crowd near the White House not to wait for the election, but that “fucking Trump” needed to be dragged out of the White House immediately.

There are also media accounts of an alleged Antifa role in the provocations. For example, Joe Hoft of Gateway Pundit reported that there was a busload of Antifa provocateurs who infiltrated the rally, citing a former FBI agent who was on site. Hoft also stated that investigative reporter Paul Sperry texted him a confirming report.

What is clear is that FBI Director Christopher Wray, key to the team that blinded and misdirected President Donald Trump this year, is a heavily compromised fellow in his announced effort to investigate who provoked the trouble. His FBI put out a call on the morning of Jan. 7: “If you have witnessed unlawful violent actions we urge you to submit any information,

photos or videos that could be relevant at [fbi.gov/USCapitol](https://www.fbi.gov/USCapitol).” President Trump would be well advised to get a serious investigation going.

## **Terror Campaign Targets Pro-Trump Republican Lawmakers—Who’s Next?**

Jan. 7 (EIRNS)—To get a sense of the terror operations being waged against Republican legislators at the federal and state level who have had the courage to challenge the vote fraud that occurred in several swing states during the Nov. 3 general election, look at the situation facing Pennsylvania State Sen. Doug Mastriano, a Republican who has worked with the Schiller Institute and LaRouche organization in exposing vote fraud in that state. Because he participated in yesterday’s pro-Trump rally in Washington, D.C., state Democratic Sen. Brian Sims charged in a tweet yesterday that Mastriano “BREAKING: We’ve learned that PA Senator @dougmastriano was heavily involved in today’s insurrection in the Nation’s Capitol. After weeks of seditious conspiracies his actions have grown grossly and predictably dangerous and I join @SenTimKearney in calling for his resignation!” Kearny joined in the McCarthyite rampage, tweeting that Mastriano had “actively organized a violent insurrection” to prevent a “peaceful transfer of power.” [Mastriano](#) issued a statement on his Senate website that “as a military veteran and retired colonel” he denounced the violence, and said that “When it was apparent that this was no longer a peaceful protest,” he and the people he was with “made our way out of the area. At no point did we enter the Capitol building, walk on the Capitol steps or go beyond police lines.”

In recent weeks, liberal media and violence-prone groups such as Antifa have specifically targeted pro-Trump Republican legislators, labeling them “traitors” and promoters of “sedition” and insurrection against the established order [sic] for demanding an investigation of vote fraud. Apparently, the mere mention of the word “vote fraud,” qualifies one as an insurrectionist. The Daily Beast, among others, summarized the Big Lie: “Claims of fraud incited the violence.”

On Jan. 4, members of Antifa gathered in front of the Washington, D.C. home of Sen. Josh Hawley (R-MO), vandalized his home, and threatened his family, because Hawley planned to challenge Joe Biden's electors in Pennsylvania at the Jan. 6 Joint Session of Congress. It's instructive that in its Jan. 9 issue, the City of London's rag *The Economist* also targetted Hawley, describing him as an "insurrectionist" and a "*golpista*"—referring to Latin American coup-mongers, or putschists, who claimed to "be trying to protect democracy, not overthrow it." Hawley had the nerve to declare that "millions of voters' concerns about election integrity deserve to be heard," the British Empire weekly wrote.

### **Obama Accuses, Of Course Trump Incited Violence, with G.W. Bush, Bill Clinton, Bill Barr All in Lockstep**

Jan. 7 (EIRNS)—In a nauseating display of self-righteousness hypocrisy and *Gleichschaltung*, former President Barack Obama, the man who actually intends to run Joe Biden's Administration, and who enjoys killing people, posted his statement last night on Twitter proclaiming that "history will rightly remember today's violence at the Capitol, incited by a sitting President ... as a moment of great dishonor and shame for our nation. But we'd be kidding ourselves if we treated it as a total surprise." Blame should be placed on the Republican Party, Obama insisted, "and its accompanying media ecosystem, for not telling Trump supporters the truth." (What truth is that? That the existing system shouldn't be challenged? Accept things as they are even if it kills you?) As a result, Obama lectured, "their fantasy narrative has spiraled further and further from reality, and it builds upon years of sown resentments. Now we're seeing the consequences, whipped up into a violent crescendo."

Obama pressed on that Republican leaders will now have to choose, either to keep following Trump's agenda and set off more "raging fires," or to come back to reality, be safe, and "choose America"—with Joe Biden's British Empire program to "restore a common purpose to our politics."

Equally nauseating was the pathetic former President Bill Clinton, whose statement decried the "assault on the Capitol, our Constitution and

our country.” Trump has spent four years of engaging in “poison politics, spreading deliberate misinformation, sowing distrust in our system and pitting Americans against each other.” It was Trump who “lit the match” for yesterday’s events, he charged, to “overturn the results of an election he lost” (to a man who couldn’t get a round dozen to a rally). Former Republican President George W. Bush was a tad more cautious, not naming Trump directly, but decrying that the assault on the Capitol has been “undertaken by people whose passions have been inflamed by falsehoods and false hopes”—i.e., by those fighting against fraud-based assault on the American election.

Lastly, former Attorney General Bill Barr, demonstrating how right President Trump was to fire him, although too late, proclaimed that Trump’s “conduct” was “a betrayal of the Presidency, of his Office and supporters.” That he “orchestrated a mob to pressure Congress is inexcusable,” Barr lied.

### **Many Resignations from Trump Administration**

Jan. 7 (EIRNS)—Several leading members of the Trump Administration resigned today, claiming they were shocked over the violent events that occurred in the Capitol yesterday. Among those who resigned are National Security Adviser Robert O’Brien; Transportation Secretary Elaine Chao; Education Secretary Betsy DeVos; Special Envoy to Northern Ireland Mick Mulvaney; Deputy National Security Adviser Matt Pottinger; Ryan Tully, Senior Advisor for European and Russian Affairs at the National Security Council; Deputy Assistant Secretary of Commerce for Intelligence and Security John Costello; and Tyler Goodspeed, acting chairman of the White House Council of Economic Advisers.

## **SCIENCE AND INFRASTRUCTURE**

### **China’s Spacecraft Is Closing In on Mars**

Jan. 7 (EIRNS)—China’s Mars probe, Tianwen-1, has been navigating in deep space since it was launched on July 21. It will arrive at Mars and enter

orbit on Feb. 10, China National Space Administration has said, reports Andrew Jones for Space News. But its (still-unnamed) lander/rover will not immediately be deployed to the surface, but could spend three months in orbit.

Unlike landing on the Moon, Mars is a dynamic planet, with seasons, weather, and dust storms. The orbiter will take images of the primary landing site, getting the rover ready to land. China is doing what no other country has attempted: On its very first mission to Mars, it is sending an orbiter plus a lander/rover, while other countries sent just orbiters on their first missions.

Also reaching Mars next month, is the U.A.E.'s orbiter Hope, and NASA's Curiosity-sized rover, Perseverance.

### **China Unveils Creation of a Quantum Communications Network Spanning 4,600 Km**

Jan. 7 (EIRNS)—Chinese scientists have set up an integrated quantum network that combines 700 fiber and two ground-to-satellite links and realized quantum key distribution between more than 150 users over a combined distance of 4,600 km. This could become an entirely safe communications network that can't be hacked.

In the future, quantum communication will be applied in fields of finance, political affairs and national defense. A whole industry chain, and eventually, a truly secure quantum internet will be possible, said project leader Pan Jianwei from the University of Science and Technology of China at Hefei. Based on the laws of quantum physics, quantum communications has ultra-high security.

According to the Chinese report, it is impossible to wiretap, intercept or crack the information since the quantum state of a photon that transmits data along optical fibers will "collapse" once it is wiretapped. In the quantum network, several services such as video calls, audio calls, facsimile, text transmissions and file transmissions have been realized for

technological verification and real-world demonstrations. Chinese businesses, including two banks, have used the network.
